Welcome to Cardiology 2007



On behalf of the Organizing Committee and The Cardiac Center at The Children's Hospital of Philadelphia, welcome to Cardiology 2007: our 10th Annual Post Graduate Course in Pediatric Cardiovascular Disease. Once again, we have planned an ambitious, comprehensive, multidisciplinary set of topics, presented by internationally renowned faculty. While there are many excellent meetings for sub-specialists in echocardiography, interventional catheterization, cardiac intensive care, cardiovascular nursing, cardiac anesthesia and surgery, we are most proud of bringing together ALL of those who care for children with heart disease to one location, to discuss issues common across disciplines, and to participate in smaller, discipline-specific breakout sessions.

As of the beginning of February, we were anticipating 750 attendees—55% of whom were physicians, 15% advanced practice nurses, 20% pediatric and intensive care nurses, and 10% allied health professionals, including perfusionists, pharmacists, respiratory therapists, physician assistants, sonographers and administrators. The attendee mix represents essentially all of the necessary aspects to care for children with cardiovascular disease, and their families.

It is a very exciting time for our field. Congenital heart disease was almost universally lethal 50 years ago; now, virtually every form of CHD is amenable to surgical or transcatheter intervention. Exceptional progress has been made in diagnostics, surgical therapy, intensive care, anesthesia and nursing – especially in the last 25 years since the introduction of prostaglandin, the availability of non-invasive diagnostic imaging with portable echocardiography and constant improvements in surgery and car-

diopulmonary bypass. *Survival is now expected, and can no longer serve as the only measure of 'outcome.'* As we enter the next era of care, we must tackle a number of important issues: How can we define and disseminate "Best Practice Guidelines"? What is to become of the growing population of adults with CHD? How can we provide the safest care possible for our patients? How do we critically review the literature, and reports of new therapies? How should new innovative therapies be monitored? How can we improve the quality of life of our current and future patients?

One of our major goals of this particular meeting is for the participants to return to their individual practices with a greater understanding of the variability in care that exists in our field, with equally good results across centers despite very differing

management strategies. Keep an open mind to new ideas, question your institutional dogma, and above all, remain inquisitive, enthusiastic and slightly skeptical—all at the same time!

New This Year: We are trying a few new things this year, and would very much appreciate your feedback in the course evaluations. Tomorrow, on 2/22/07, one afternoon breakout session will be devoted to issues that confront physicians in training and junior staff: how to get a job, choose a mentor, get funding, negotiate salary and balancing work and real life. On Saturday, 2/24/07, we will have two large plenary sessions using a digital audience response system. In the morning, we will hold **"The World's Biggest Surgical Conference"** discussing common and complex CHD management, and at the end of the day, a multidisciplinary session examining practice variability. On 2/22/07 and 2/24/07, hands-on Sunrise Breakfast Sessions will be held from 7-8 AM. (See elsewhere for the details on tomorrow's sessions.) A special Nursing Research Symposium will be held on Saturday AM, 2/24/07, with practical advice and mentoring from the incredibly talented and accomplished nursing faculty, as well as new nursing research presentations. Finally, 5 interesting Debates will be held throughout the meeting. [Also, don't miss Dr. Mike Brook starring as Alex Trebek hosting "Cardiology Jeopardy!" during lunch on Friday, 2/23/07!]

In addition to the new research presented throughout the meeting, we received over 100 abstract submissions, 64 of which will be presented in two separate poster sessions. The top finalists for the 4th Outstanding Investigator Award will present their work during the featured research session on Friday, 2/23/07; the winner will be honored at 11:15 AM on Saturday, following the named lectures. Finalists include Dr. Kirstin Odegard (Children's Hospital, Boston), Dr. John Costello (Children's Hospital, Boston), and Dr. Jon Kaufman (The University of Colorado and Children's Hospital, Denver).

This year's **Plenary Sessions** include overviews of cardiopulmonary resuscitation (2/21/07), double outlet right ventricle (2/22/07), coronary artery disease (2/22/07), improving patient safety (2/23/07) and heterotaxy syndrome/isomerism (2/25/07). In addition, sub-specialty breakout sessions will be held throughout the meeting in echocardiography, nursing, perfusion, intensive care, administration and outpatient cardiology. A **Live Fetal Imaging** session will be held on 2/23/07.
